NEW - UCPATH Announcements Channel

A New Communications Tool for You

To improve timely communications of UCPATH information to transactors, the UCI UCPATH training team has opened a Microsoft Teams group for important announcements. This enables us to share announcements quickly and easily on topics such as:

How to Add the UCPATH Announcements Channel:

Look for an email from UCI UCPATH mailbox with a link to this new TEAMS channel or [click here](#) to opt-in.

If you have MS Teams:

- Once you receive the email, click the link to opt-in and join the group.
- Please look for a **UCPath Announcements** channel to be added to your MS Teams account.

If you do NOT have Microsoft Teams on your computer:

- Open a ticket with your local IT support, or call the UCI OIT help desk and request to have MS Teams installed on your computer.
- After install, please refer to email with link to opt-in and join group.

Note: Chat and other interactive response features are disabled for this channel.

Reminder: Changes to How Bookmarks Work in UCPATH

On October 15, 2022, UCPATH will change how PeopleSoft Bookmarks work in UCPATH as part of a larger initiative for improved, more intuitive navigation.

What is Changing:

- UCPATH Online pages and links that reside on the UCPATH portal will continue to be saved in Bookmarks on your UCPATH online dashboard. Examples: *Retro Pay Matrix, Payroll Calendar, Benefits Billing Calendars, etc.*
 - UCPATH PeopleSoft pages are accessed from the PeopleSoft menu in UCPATH. When this change is implemented, these pages can only be saved as Favorites

within PeopleSoft. Examples: *Template Transactions, PayPath Actions, Modify a Person, etc.*

How to prepare for this change:

- Prior to October 15, determine bookmarks currently on the UCPATH portal for UCPATH PeopleSoft pages
- Add those bookmarks as Favorites within UCPATH PeopleSoft

Continuous Improvement Efforts and Accomplishments

The UCI UCPATH team is continually seeking ways to improve systems and processes for transactors. Below is an overview of recent efforts and accomplishments.

EEC Reporting Drives Process Improvement

Cathy Ruggera and Marie Rademaker-Alford successfully led a Lean Six Sigma (LSS) Yellow Belt project to develop the ability to analyze and report on the Employee Experience Center (EEC) cases submitted by transactors to the UCI UCPATH support team. The objective was to develop a quarterly analysis report that helps the team align training tools, resources, and communication for transactors. The team launched the project in November 2021 and developed the methodology to track the data by December 2021. The new report was created in March 2022 and is currently being used to drive process improvements.

Transactor Web Page Improvements in Process

Did You Know...?

When an employee is eligible for benefits, they will receive a system generated email notice and a benefits package via mail advising them to complete their enrollment online. It is important for location teams to also ensure that new employees are aware of their benefits eligibility and encourage them to enroll online in the first 30 days of eligibility.
